ASSIGNMENT OF JUDGES  
JULY 6, 2026 THROUGH JANUARY 3, 2027

WHEREAS, in accordance with the provisions of the Tenth Judicial Circuit Court's Local Rule One, which provides for the assignment of judges to sections and divisions of the court; it is hereby **ORDERED** that:

1. Administrative Order No. 1-1.68 is modified as outlined herein to provide for the assignment of judges to sections and divisions of the court for the period beginning July 6, 2026 and ending January 3, 2027.
2. Effective July 6, 2026, the Polk, Highlands, and Hardee County Clerks of Courts shall assign cases to the sections and divisions of the court in accordance with the ratio shown in Exhibit A (attached and incorporated herein), which lists the assignments of judges to sections and apportionment of new caseload assignments.
3. The judges are assigned additional duties, as outlined in Exhibits B, C, D, E, and F (all attached and incorporated herein), in order to provide adequate judicial manpower for various divisions of the court.
4. This Order is effective immediately for planning and implementation as indicated herein and shall **SUPERSEDE** Administrative Order No. 1-1.68 on July 6, 2026.
