**ADMINISTRATIVE ORDER NO. 2-77.0**

**IN RE: FEES FOR PARTICIPATION IN POLK  
COUNTY TREATMENT-BASED DRUG COURT**

**WHEREAS**, §397.334, Florida Statutes, establishes within the State of Florida “treatment-based drug courts”; and

**WHEREAS**, the Polk County Treatment-Based Drug Court Program (hereinafter “Polk County Drug Court”) was established in 1993; and


**WHEREAS**, all participants in Polk County Drug Court programs are required to pay monthly treatment fees, and

**WHEREAS**, the Polk County Drug Court is funded based on fees and grant funding;

It is therefore, **ORDERED** that:

1. The current Polk County Drug Court fees are set out in Attachment A hereto. Attachment A may be modified as necessary by special order.
2. The Chief Judge may modify monthly treatment fees listed in Attachment A on a case by case basis upon a showing of hardship by the participant.
3. Any of the above fees may be suspended by the presiding judge as long as separate funding is available to cover the costs of the programs and services.
4. This order is effective immediately.

**ATTACHMENT A**  
**(effective February 16, 2026)**

**Polk County Treatment-Based Drug Court Fees**

1. A one-time assessment fee of \$135.00 (includes a ten panel drug screen) shall be paid prior to entering one of the below programs:
  - a. Adult Drug Court (diversion misdemeanor);
  - b. Adult Drug Court (diversion felony);
  - c. DUI Drug Court;
  - d. Post Adjudication Drug Court (misdemeanor); or
  - e. Post Adjudication Drug Court (felony). The one-time assessment fee of \$135.00 is waived as long as reoccurring funds are available through grant money or money appropriated by the Legislature.
  
2. Monthly Treatment Fees:
  - a. Adult Drug Court (diversion misdemeanor): \$85.00 per month;
  - b. Adult Drug Court (diversion felony): \$95.00 per month;
  - c. DUI Drug Court: \$200.00 per month;
  - d. Post Adjudication Drug Court (misdemeanor): \$75.00 per month; and
  - e. Post Adjudication Drug Court (felony): The \$75.00 per month treatment fee is waived as long as reoccurring funds are available through grant money or money appropriated by the Legislature.
  
3. Drug Screen Fees:
  - a. Adult Drug Court (diversion misdemeanor): \$35.00 per test;
  - b. Adult Drug Court (diversion felony): \$35.00 per test;
  - c. DUI Drug Court: \$35.00 per test;
  - d. Post Adjudication Drug Court (misdemeanor): \$35.00 per test
  - e. Post Adjudication Drug Court (felony): The \$35.00 per test fee is waived as long as reoccurring funds are available through grant money or money appropriated by the Legislature;
  - f. OSCA: 35.00 per test;
  - g. DCF (dependency/juvenile drug court and BHC): \$33.00 per test;
  - h. State Attorney Clients: \$45.00 per test;
  - i. Contested Drug Screens (done when a participant contests a drug screen): \$65.00 per test (fee must be paid prior to the contested drug screen being sent to outside company for further testing);
  - j. Department of Juvenile Justice: \$35.00 per test;
  - k. Juvenile Drug Court Clients (DJJ referrals): \$35.00 per test;
  - l. Pre-Trial Services: \$35.00 per test;
  - m. Department of Children and Families (without DCF referral): \$35.00 per test;

- n. Department of Children and Families - Contested Drug Screens (done when a participant contests a drug screen: \$33.00 per test.
- o. Court Ordered from Juvenile Judge: \$35.00 per test;
- p. Juvenile Self-Referrals: \$35.00 per test;
- q. Polk County Probation (on-site testing): \$35.00 per test;
- r. Court Ordered from Judge (other than Juvenile or Dependency): \$45.00 per test;
- s. Adult Self-Referrals: \$45.00 per test; and
- t. Breathalyzer Test: \$20.00 per test.

4. Miscellaneous Fees:

- a. ID Cards: \$20.00 per card; and
- b. Copies of records: \$1.00 per page.
