ADMINISTRATIVE ORDER NO. 3-44.0

**IN RE: RE-CREATION OF POLK COUNTY CIVIL
SECTION 11 AND REASSIGNMENT OF CASES**

WHEREAS, the Civil Division of the Circuit Court in Polk County is presently divided into four sections; and

WHEREAS, in order to promote judicial economy, maximize judicial resources, and provide for the prompt and efficient administration of justice in this circuit, it is necessary to recreate Section 11 and reassign cases from the existing four civil sections to Section 11; and

WHEREAS, in accordance with article V, section 2, Florida Constitution; section 43.26, Florida Statutes; and Florida Rule of General Practice and Judicial Administration 2.215;

NOW, THEREFORE, it is ORDERED that:

1. RE-CREATION: Section 11 of the Polk County Circuit Court, which was terminated on September 1, 2023, is recreated effective May 1, 2026, subject to the reassignment of cases as set forth in this Order.
2. REASSIGNMENT OF CASES: On May 1, 2026, the Polk County Clerk of the Court (hereinafter "Clerk") shall randomly reassign open, reopened, and closed cases from the existing four Polk County civil sections to Section 11, except that no eminent domain cases shall be reassigned to Section 11. The cases shall initially be reassigned to equalize the number of cases assigned to the five sections and then an additional 190 cases shall be reassigned roughly equally from each of the existing four sections into Section 11. A list of the open and reopened cases to be reassigned is attached hereto as Attachment A.
3. NEWLY FILED CASES: On July 1, 2026, the Polk County Clerk of Courts shall begin randomly assigning newly filed cases to Section 11 along with the remaining four civil sections, except that no eminent domain cases shall be assigned to Section 11.
4. TRIALS AND HEARINGS SCHEDULED BETWEEN MAY 1, 2026, AND JUNE 30, 2026: Between May 1, 2026, and June 30, 2026, the judge currently assigned to the

cases listed in Attachment A will continue to hold and preside over presently scheduled hearings and trials, schedule and hear all matters which can be heard on the section's calendar prior to July 1, 2026, and otherwise take judicial action on those cases listed in Attachment A. The currently assigned judge will schedule hearings to be heard on or after July 1, 2026, on the Section 11 calendar.

5. EFFECTIVE DATE: This Administrative Order is effective on May 1, 2026.
