You have now purchased this packet or received this checklist to proceed as a self-represented (“pro se”) litigant. **You must follow the procedure of each required form. Please read each form carefully. Forms may be downloaded from [www.flcourts.org](http://www.flcourts.org) – (Self-Help Information/Family Law Forms).**

After you have completed and filed the original forms with the Clerk of Court (Family Law Division), you must contact the Self-Help Program at **(863) 402-6618** or email [ljbass@jud10.flcourts.org](mailto:ljbass@jud10.flcourts.org) to request a review of your file. Be sure to have your case number available for reference.

**\*Address Changes:** If your address changes at any time during this proceeding, please complete **Form 12.915 (Designation of Current Address & Email Address)** and file with the Clerk of Court. The Court will not rely on forwarding address information with the U. S. Postal Service.

- Settlement Agreement (if any - signed by both parties)
- Family Law Financial Affidavits (filed by both parties)
- Bureau of Vital Statistics (BVS) Form
- Proposed Final Judgment (with self-addressed stamped envelopes for each party)
